PROCEDURE FOR OBTAINING A TREE FELLING PERMIT IN GOMBE STATE

Guiding Laws & Regulations

In accordance with the provisions of the **Gombe State Environmental Sanitation** and **Protection Agency Law, 2005** (as amended), individuals and organizations seeking to obtain a tree felling permit in Gombe State are required to follow the established application process. This process aims to regulate deforestation and promote sustainable forestry practices in the state.

STEP 1: Start Your Application by Obtaining an Application Form

- Visit the Gombe State Ministry of Environment and Forestry office at Government House Complex, Gombe, to obtain the application form.

STEP 2: Prepare All Relevant Documents

Applicants must provide the following documents:

- a. Land Ownership Proof: Certified copy of the Certificate of Occupancy (C of O) or land title document.
- b. Location Sketch: A site map or GPS coordinates of the tree location prepared by a registered surveyor.
- c. Environmental Impact Statement: A brief report highlighting the impact of the proposed tree felling on the environment.
- d. Affidavit of Purpose: A sworn affidavit stating the purpose of tree felling (e.g., commercial use, personal use).

- e. Approval from Community Leaders: Endorsement or approval letter from the local community head or ward leader where the trees are located.
- f. Tax Clearance Certificate: A valid tax clearance certificate from the Gombe State Internal Revenue Service.

STEP 3: Pay Applicable Fees

- Payment of applicable fees can be made via:
- Gombe State TSA Payment Portal: www.irs.gm.gov.ng
- Any recognised bank in Gombe State using the TSA Online payment platform via Pay a biller (remita.net).
- At the Ministry of Environment and Forestry office via POS or bank draft.
- Keep the payment receipt as proof of payment.

STEP 4: Submit Completed Application

- Submit the completed application form, supporting documents, and proof of payment at the Ministry's Customer Service Desk [Insert address].
- Upon submission, applicants will receive:
- A Reference Number for their application.
- An Acknowledgement Letter within 5 working days.

STEP 5: Site Inspection & Review

- Officials from the Ministry will conduct a site inspection within 7 working days to verify the details provided and assess the environmental impact.
- Applicants will be notified of the inspection date via SMS or email.

STEP 6: Permit Approval

- Applications will be processed within 14 working days after the site inspection.
- Approved applicants will receive their Tree Felling Permit via email or physical collection at the Ministry office.

Fee structure

Service Type	Fee (N)	Description
Application Processing Fee	2,000	Covers the cost of processing the tree felling permit application.
Inspection Fee	3,000	For site inspection by forestry officials to assess the trees intended for felling.
Permit Issuance Fee	5,000	Fee for the issuance of the tree felling permit.
Replanting Contribution	1,000/tree	A fee per tree felled to support reforestation efforts in the state.
Penalty for Unauthorized Tree Felling	10,000	Applied to cases where tree felling begins without prior approval from the Ministry.
